METHODS AND OBJECTIVES OF INFORMATION PROCESSING

The information relayed to us will be will be conserved and processed according to the security and secrecy measures foreseen by the Legislative Decree of June 30th 2003, n. 196, and will only be used in order to perform the tasks entrusted to us and to pass on communications of an informative nature from CARLO PIGNATELLI S.p.A., as well as for legal obligations.
